Treasurer:

- As of 12/31, we had \$246,660.52 in the operating account. Any excess funds are to be transferred to the shared reserve account after accounting for 2020 expenses paid in 2021 and revenue for 2021 received in 2020. Joe offered a preliminary analysis of the amount to be transferred, which he suggested can be finalized in the next couple weeks
- The 2020 taxes are based upon 2019. Joe does have a concern that our tax liability could be significantly higher given the surplus we ran in 2020. We can do a final true up once the actual amount is known. The current shared reserve balance is \$30,906.59
- IMFs:

\$7,200.00 was transferred from the operating account to the capital account today for the Q4 2020 IMFs received. This brings the current capital account balance to \$120,133.60.

Merchant Fees:

Fees associated with accepting online payments was \$121.51 in December.

- Q Fees online? 100.00 start up was in Nov. What are people using for payment that we are getting charges for? Question if it was only for debit cards? A Joe will track it down and include it in reports going forward.
