- Initial Membership Dues for the quarter ending March 31 were \$2,400 and will be transferred to the capital reserve account in April.
- The tax return for 2020 was finalized with a tax liability of \$18,698.00 and professional fees of \$1,000. At the end of 2020, \$5,400 was held in the operating account for future taxes (balance of excess funds get transferred to the shared reserve at year end) and \$850 for professional fees. \$13,448 was transferred back to the operating account to cover the difference:

Taxes: \$18,698.00Prep: \$1,000.00Total: \$19,698.00
