 - 2 properties that have access to Paulinskill as lakefront owners are not deeded into PLA. They are interested in becoming part of the PLA.
 - Suzanne has worked at engaging in a lot of correspondence w our attorney without traction
 - She and Linda came up with an idea that they offered to the Board: Create a new level of membership for those whose properties are not deeded in. They agree to pay X except for right to use the grounds. They cannot vote or be part of the board. Pay for that "level" of membership.
 - Need to figure out that value, get approval from the board, put in newsletter, special vote (before summer)
 - Only for properties that are lake front that are not deeded.
 - Scott This would require change to bylaws.

- Q what about insurance? Are they covered? A yes
- o 3 on vail and 2 on Newton Swartswood road.
- Concern about precedent and how the Board might explain that this privilege is only for those who are lakefront?
- Concern w attorney not doing her job. Do we need to find a different attorney?
- The PLA takes care of the properties from the bridge down.
- We do not know why those properties were never included in our deed.
- Linda Question we are trying to have answered by our attorney: Is it possible to change their deed and our deed to add these properties to the lake.
- That long term dues requirement is beneficial if it takes place.
- Get Donna on the phone with some concrete answers to the cost of changing the deeds.
- Other lakes wish they never had the amended membership because special membership can be confusing as to when to "pay in".
- Linda to call Donna the lawyer and get an answer. Deeding is the best way to go. Check w tax accountant on revenue not generated by dues.
- Pati to contact Dolan and Dolan for pricing on homeowners association

 meeting to spend capital improvement on that. Rob understands that it was 1986 this
 footbridge was done.
