Entertainment

- March 3 Firehouse 1 Trivia Night
- The pole Without a guidewire. It was going to be installed with a guidewire running parallel to the back of the volleyball court which would not be good.
- Also, there is a transformer on West End and South Shore which Dave has been trying to get them to use. Dave was told the transformer was no good.
- When they came out to look at everything, they decided that the plan is; to put the pole where we marked it. We can rewrite the job. There is a guide pole by the stream that attaches to the pole across to West End and South Shore. They have to set a new pole and put the guide wire on that pole. We can set the second pole where we want it at the edge of the parking lot and we are good to go. There is not much to design. This project is in the submission process because the guide pole is a UT pole (joint use). They will submit to them, no transformer is needed and this saves us a bunch of money.
- We set it close to the edge of the parking lot rather than where we were going to originally. It will shine light on more areas (ballfield too). It avoids trenching and it is a better plan. We have a lot of attention now because we made it to the right people.
- No electrical contracted yet. It is too early. We need the exact location after submission is approved.
- They may cover tree trimming. There is not much to do.
- Forward progress is in place

President

- In contact with Planet Network (not to promote) but, if Planet Network get 250 homes with signed contracts they will provide internet at beaches for security cameras. Scott has a call out to Planet Network.
