## **Membership Comments/Input**

- A Member (*not sure who?*) submitted questions to Cindy. Scott asked to read them:
  - Why do we as a community need to be concerned about how others are using the lake? What is the PLA responsibility and what is not?
  - This question pertains to posts on the unofficial Facebook page
    - Q = oversized boat post
      - A = launches above the clausway being discussed with Fish and Game to help clarify understandings
    - Q pollution of lake w lawn clippings post
      - A leaves naturally fall into the lake. Intentionally blowing a quantity of leaves into our lake creates algae growth, a danger to the quality of our water quality and our communities access to clean water. We strive to protect our water from all fertilizer, including excessive leaf compost.
    - Explanation that members posted a retort to basically "mind own business" and this member wanted to have the explanation for these posts validated. Board views these posts as Public Service Announcements (PSA)
- Courtney Johansen -
  - Scott shared his intent to appoint Courtney to the Financial Secretary position when Linda McSweeny leaves the position to become Treasurer. Scott asked Courtney to tell us a little about herself.

    - coalition will get back to Scott ~ Scott wants to get this information in writing for us
